The University of Warwick is a world class higher education institution, ranked 10th in the UK and 69th in the world. Now in its 60th year, the University is currently celebrating six decades of transformative education, research and innovation.

The University is recognised as a leading employer, with over 7,300 direct employees, playing an important role within the local economy as well as being of national and international importance.

The University of Warwick was founded in 1965 and has had approved masterplans throughout its history, most recently the 2009 Masterplan Outline Planning Permission and the 2018 Capital Plan Hybrid Permission, which have guided recent developments on campus such as the Lord Bhattacharyya Building, Oculus, the Slate, the Sports Hub, Cryfield Village, the IBRB at Gibbet Hill, the Warwick Arts Centre extension, the new Faculty of Arts Building, along with two new multi-storey car parks at Lynchgate and Kirby Corner.

The next phase of development is now underway, with proposals for a new Social Sciences Quarter including new buildings for the Business School, and a multi-

phase refresh of science, technology, engineering and mathematics (STEM) facilities around a new Science and Engineering Precinct in the heart of campus, both being granted planning permission in 2024.

The University has worked collaboratively with the City Council and Warwick District Council over the last 12 months to prepare a Supplementary Planning Document for the campus which was adopted by both authorities in December 2024. The SPD reflects the University's Capital Plan for future investment in the campus up to 2033.

The recognition and support that Policy JE1 gives to the growth of the city's Universities, and how this can maximise the economic development and other community benefits associated with them, at part I, is supported and welcomed. The commitment the Council gives to working positively with the University at Part a of the policy, which recognises the role the University plays in promoting innovation, is also welcomed.

The University campus is home to Warwick Arts Centre multi venue arts complex which attracts c300,000 visitors a year. It is the largest arts centre in the Midlands and recently underwent a significant refurbishment and extension, reopening for events in 2021. The Warwick Arts Centre is an important visitor attraction and asset within Coventry and the wider region. Part h of Policy JE1 provides support for tourism/visitor related development at the University of Warwick campus. The recognition of the role that the Arts Centre and the wider campus makes in the tourism and visitor economy and the support given to further tourism/visitor related development here is welcomed.

Given the recent adoption of the SPD for the University campus, the University consider it would be beneficial for the SPD to be mentioned within this policy.
