It is unclear how such sites, that could also be considered green space, particularly informal green space, as categorised in the adopted Coventry City Council Green Space Strategy (2019-2024), will be protected, if the sites are part of a strategic land allocation for development, such as in Strategic Policy H2: Housing Allocations and Strategic Policy JE2: Provision of Employment Land and Premises.

Policy GE2: Green Space 1. States: Development involving the loss of green space that is of value for amenity, recreational and/or community use will not be permitted unless specifically identified as part of a strategic land use allocation ...

Policy GE3 and Policy GE2 appear to conflict with each other, and sites such as Local Wildlife Sites and Local Nature Reserves may not be afforded the protection that was intended by Policy GE3 (1).
