In relation to Policy H7, the PCCWM made the following representation to the Regulation 18 consultation:

*"The proposed update of the criteria in Policy H7 of the Local Plan are noted and **supported** by the PCCWM. In addition, it is suggested that reference to 'safety' be expanded to include reducing crime and the fear of crime. It is also considered that the policy should make reference to recommended consultation with Design Out Crime Officers (DOCO) at the pre-application and planning application stage, the need for all proposals to meet Secured by Design principles and the need for a management plan to ensure crime prevention measures are maintained."*

The Consultation Statement does not acknowledge this representation, nor is it reflected in the policy itself. However, whilst the PCCWM favours the principle of a policy which supports Gypsy and Traveller Accommodation, nevertheless he considers that further consideration should be given to his recommendations in the interests of reducing crime and the fear of crime accordingly, as set out in the justification in the representation of the PCCWM regarding Policy H13.

The PCCWM considers that reference to 'safety' in Policy H7 should be expanded to include reducing crime and the fear of crime. It is also considered that the policy should make reference to recommended consultation with Design Out Crime Officers (DOCO) at the pre-application and planning application stage, the need for all proposals to meet Secured by Design principles and the need for a management plan to ensure crime prevention measures are maintained.

Policy H7 should therefore be amended by the inclusion of a clause such as:

'All proposals will be expected to demonstrate how the relevant 'Secured by Design' principles have been met including the outcome of consultation with Design Out Crime Officers (DOCO) at the pre-application stage and preparation of a management plan to demonstrate how the crime prevention measures will be maintained.'
