Thank you for your request for information relating to Parking surveys in support of planning application .

You have requested the following information:

Please provide any parking surveys submitted in support of planning applications for HMOs or residential conversions within 300m of CV5 6JU in the past 5 years.

Clarification - By parking surveys, I am referring to an assessment of the local parking situation, typically carried out by a specialist consultancy. This would usually involve:

- A physical survey of the area surrounding the property to determine parking availability and occupancy levels at various times of day.**
- Data collection on the number of vehicles parked on-street within a defined radius.**
- Evidence to support that the development would not have a detrimental impact on existing parking provision, especially in light of any Article 4 restrictions or local parking pressures.**

The aim is to provide objective data to support our planning application and address any concerns regarding parking stress in the area.

The information you requested falls under the exemption(s) in Section 21 of the Freedom of Information Act 2000, which relates to 'information reasonably accessible to the applicant by other means.'
