Thank you for your request for information relating to Widening of Spon End.

You have requested the following information:

I wish to understand if widening Spon End [The Project] achieved its objectives.

1. Can I please see any monitoring of air quality in Coventry for 3 years before the project, and any monitoring since the widening of Spon End.

2. Also monitoring of traffic on Spon End and the Holyhead road before and after the project.

The average weekday traffic flows for lower Holyhead Road and Spon End from 2018 to present is below.

Please note, there is some missing data for Spon End as surveys were not undertaken during construction activities. Figures for Holyhead Road for 2021 23 were also influenced by the works on Spon End and at Ring Road Junction 7.
