Thank you for your request for information relating to Abandoned Vehicles in Your Local Authority.

You have requested the following information:

Under the Freedom of Information Act 2000, I would like to request the following information regarding abandoned vehicles within your local authority area, covering the past five calendar years (or the maximum available range):

1. The number of abandoned vehicle reports received per year.

The total number of reports of abandoned vehicles received over the past five calendar years including this year, are as follows:

2. The number of confirmed abandoned vehicles removed per year.

The total number of confirmed abandoned vehicles removed (assumed with the outcome of vehicles which were destroyed, claimed or returned) over the past 5 calendar years are as follows:

2025 77

3. The most common makes and models of abandoned vehicles.
