Thank you for your request for information relating to External Wall Systems (Cladding) and Fire Safety Assessments.

You have requested the following information:

Under the Freedom of Information Act 2000, I am writing to request information regarding buildings in your borough that may have cladding-related fire safety issues and require further assessment or remediation.

Specifically, I am requesting:

1. A list of residential buildings over 11 metres in height in your borough that:

- **Have not yet completed a Fire Risk Appraisal of External Walls (FRAEW); or**
- **Have completed a FRAEW but identified remediation works are required or pending; or**
- **Have been submitted to the Building Safety Fund (BSF), Cladding Safety Scheme (CSS), or ACM Remediation Programme but are still at “in-programme” or “pre-start” status.**

Not applicable. Coventry City Council has no such residential buildings.

2. For each building, please provide (where available):

- **Building name/address or UPRN (if redaction is required, please include postcode/borough segment)**
- **The current remediation stage (e.g., FRAEW pending, funding applied, works underway)**

- **Type of cladding identified (if known)**
- **Whether an EWS1 form has been completed**
- **Whether remedial works are currently planned, underway, or completed**

3. Additionally, please confirm whether the council holds any records of:

- **Buildings where combustible material has been identified but no remediation plan is yet in place**
- **Social housing or council-owned blocks known to require or be awaiting external wall system remediation**
