Thank you for your request for information relating to Supported Living provision for both Adults and Children.

You have requested the following information:

Under the Freedom of Information Act 2000, I would like to request the following information for the financial year April 2024- April 2025 if more recent data is available):

We advise supported living is a service delivered by Adult Services so there is no spend in Children's Services.

1. The total amount spent on Supported Living across Adult and Children's provision.

Adults (interpreting this as referring to 18-64 and 65+) spend in 2024/25 was £4.924m which comes from the ASCFR submitted recently and is usually published around October each year.

2. The number of Supported Living packages that are spot/ unregulated purchased.

Adult Services operate a Supported Living Framework for all in city supported living. We currently have one provider who has a spot contract outside of the framework supporting nine citizens. For out of city placements we follow an out of city contract process.

3. The current needs for Supported Living provision that are on a waiting list (including number of cases and type of needs, if recorded).

Adult Services do not hold a waiting list.

4. A list of off-contract providers currently used, along with the areas they support.

Adults - For in city provision we have one provider who has a spot contract outside of the supported living framework who support MH and LD citizens.

Children's: The information you requested falls under the exemption(s) in Section 21 of the Freedom of Information Act 2000, which relates to 'information reasonably accessible to the applicant by other means.'
