

City of Coventry (Radford Road)
(20mph Speed Limit Zone) Order 2025

Coventry City Council, in exercise of their powers under Section 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended) ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order: -

1. The Order shall come into operation on the **XX day of XXX 2025**, and may be cited as the City of Coventry (Radford Road) (20mph Speed Limit Zone) Order 2025.
- 2 (i) In this Order:-
 - (a) a reference to an Article followed by a number is a reference to the Article of this number so numbered;
 - (b) the following expressions shall have the meanings assigned to them:-

"2016 Regulations" means the Traffic Signs Regulations and General Directions 2016 and includes any enactment or re-enactment or amendment thereto;

"cause" includes permit and causing shall be construed accordingly

"enactment" means any enactment, whether public general or local and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment;

"pedal cycle" has the same meaning as in Schedule 1 of the Traffic Signs Regulations and General Directions 2016;

"road" shall have the same meaning ascribed to it by Section 142 of the Act

 - (i) "vehicle" means a mechanically and/or electrically propelled vehicle intended or adapted for use on the Road; and/or
 - (ii) a pedal cycle in actual use for the purpose of cycling
 - (iii) "vehicle" which for the avoidance of doubt includes the whole or any part of a vehicle.
- (ii) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to the interpretation of an Act of Parliament
- (iii) Reference to any Statutory Instrument, Act, Regulations or Order referred to in this Order shall be read and construed as the Statutory Instrument, Act, Regulations or Order as amended, varied, re-enacted or revoked.
3. Save as provided in Article 4 of this Order, no person shall cause or permit any vehicle to be ridden or driven at a speed exceeding twenty miles per hour on the lengths of road specified in the Schedule to this Order.

4. Nothing in Article 3 of this Order shall apply to any vehicle being used for Police, Fire or Ambulance purposes in circumstances of emergency.
5. In the event any provision of this Order conflicts or is inconsistent with any provision of any other order made or having effect as if made under the Act, or by any other enactment, the provisions of this Order shall prevail and take precedence.

Road in the City of Coventry	Extents
Radford Road	From a point approximately 25 metres north of its' junction with Lawrence Saunders Road in a generally northerly direction to a point approximately 65 metres north of its' junction with Otterbrook Court.
