- Financial_year: budget year (e.g., "2025/26")
- Effective_from_date: start date of the rate (YYYY-MM-DD)
- Care_category: Residential (older people); Residential dementia (older people); Nursing (older people); Nursing dementia (older people)

- **Weekly_rate_gbp:** usual weekly rate in £ (before add-ons)
- **Fnc_included:** for nursing categories: is NHS Funded Nursing Care included? (Yes/No/Not applicable)
- **Band_or_grade:** if tiers used (e.g., Standard/Enhanced/Complex needs)
- **Band_trigger_description:** brief criteria for that band/grade (e.g., High-dependency needs per LA policy)
- **Quality_or_asset_addon:** named uplift (e.g., CQC Outstanding, ensuite, wetroom)
- **Addon_type:** “percent” or “pounds”
- **Addon_value:** numeric value (e.g., 5 = +5% or 25 = +£25)

Nursing standard - £724 excludes FNC

Nursing dementia - £765 excludes FNC

2023/24 (as at Aug 2023)

Residential - £666

Residential dementia - £742

Nursing standard - £643 excludes FNC

Nursing dementia - £710 excludes FNC
