Thank you for your request for information relating to Pothole Numbers and Repairs Data.

You have requested the following information:

For calendar years 2023 and 2024 (and 2025 to date where available):

- 1. Please provide the total number of potholes reported from all sources, broken down by:
- i) Source (e.g., public reports via portal/app, council inspections).

Please note we are unable to breakdown how many carriageway pothole jobs were raised as a result of being reported by the public and how many were raised from inspections as this information is not available. We have provided details below for both number of enquiries received from the public and for the number of jobs raised by inspectors (which includes those reported by the public and those from inspections).

Number of Carriageway pothole enquiries received

Please note the below figures are for the number of carriageway pothole enquiries received (not the number of potholes reported,) as each enquiry may have multiple potholes on it. Not all potholes reported by members of the public will result in jobs being raised for repair (as not all of the defects reported will be at intervention level).

The figures are for the average number of calendar days it has taken to complete jobs, not average number of calendar days taken to repair each pothole as each job may have multiple potholes on it.
