The information you requested falls under the exemption(s) in Section 21 of the Freedom of Information Act 2000, which relates to 'information reasonably accessible to the applicant by other means.'

The exemption applies as the information is published and publicly available to view by accessing the Council website.

You can select the year and any meeting from the drop down menus and links and the page for each meeting includes the agenda, papers and minutes. The membership of the committee, including the Chair and Deputy Chair, at that point in time is shown at the bottom of each agenda.

Appointments to the committee are made at the Council's annual meeting held each May, so the June meeting in each year will include the names of the new committee for the Council year that runs from May to May, although occasionally changes to appointments are made during the year.

The supply of information in response to a FOI/EIR request does not confer an automatic right to re-use the information. You can use any information supplied for the purposes of private study and non-commercial research without requiring further permission. Similarly, information supplied can also be re-used for the purposes of news reporting. An exception to this is photographs.
