### **STATEMENT OF REASONS**

The City of Coventry (Citywide) (Permitted Parking Area and Special Parking Area) (Designation, Waiting Restrictions, Loading Restrictions, Loading Areas and Street Parking Places) Consolidation Order 2016 – Variation 14

Several road safety concerns have been raised by local residents in regard to problems caused by drivers parking at junctions, reducing visibility of and for exiting vehicles and in other locations, such as on bends. It is proposed to install waiting restrictions at these locations to prevent parking and improve road safety. In addition, in other areas issues have been raised regarding all day commuter or itinerant parking and residents' parking schemes or controlled parking zones are proposed in these areas.

The locations referred to above where changes are proposed are detailed in Appendix A.

As part of the low carbon agenda relating to transport the Council has installed on street residential charge points across the city. There are advisory parking bays located alongside the charge points. It is proposed to install a restriction on some of these advisory bays to permit their use by Electric Vehicles only, whilst charging batteries, 8am – 10pm (7 days a week). These are detailed in Appendix B.

It is also proposed to amend Schedule 4 to create or amend the following Resident Permit Parking Only schemes:

ELIZABETH WAY – To make properties 137 to 187, Woodway Lane (odd numbers only) eligible to apply for Zone EL Parking Permits

PARADISE 1 – To make all properties in Silverton Road and properties 673 to 693, Stoney Stanton Road (odd numbers only) eligible to apply for Zone EW1 Parking Permits

THAMLEY ROAD – To make properties in Thamley Road eligible to apply for Zone TR Parking Permits

#### **REASONS**

When considering whether to make a traffic order the Council is under a duty pursuant to S.122 Road Traffic Regulation Act 1984 (as amended), to secure the expeditious, convenient and safe movement of vehicular and other traffic (including pedestrians) and the provision of suitable and adequate parking facilities on and off the highway having regard to the matters specified in S.122 (2). It is considered that the proposals will generally assist to secure the safer movement of vehicular and pedestrian traffic. Furthermore, it is considered that the proposals will affect the matters specified in S.122 (2) as follows:

(a) the desirability of securing and maintaining reasonable access to premises;

The proposals will assist with the movement of traffic and will not adversely affect access to premises.

- (bb) the strategy prepared under section 80 of the Environment Act 1995 (national air quality strategy
- (c) the importance of facilitating the passage of public service vehicles and of securing the safety and convenience of persons using or desiring to use such vehicles; and

The proposals will assist with the movement of traffic.

The restrictions are to be installed in accordance with Section 1, Road Traffic Regulation Act 1984 as it provides that the Traffic Authority may make a Traffic Regulation Order, where it appears to the Authority making the order, that it is expedient to make it –

for avoiding danger to persons or other traffic using the road or any other road or preventing the likelihood of any such danger arising

for facilitating the passage on the road or any other road of any class of traffic (including pedestrians)

The Director, Transportation and Highways has delegated powers to request the advertisement of Traffic Regulation Orders.
