No further works are planned on Holyhead Road for the LAQAP, as monitoring indicates that compliance with Government targets for nitrogen dioxide levels at this location is on track without the need for any additional measures to those already delivered (Coundon Cycle Route, Spon End Highway Improvement and Ring Road Junction 7 Improvement).

- Ring Road Junction - Remodelling of various further Ring Road junctions:
