Thank you for your request for information relating to Parking fines in the Hen lane area.

You have requested the following information:

Coventry City Council operates a residents parking permit scheme in the Hen Lane area, next to the Coventry Building Society arena. Parking restrictions apply on certain event days.

Please list the number of event days that have triggered parking restrictions in this area for the calendar years 2026, 2025 and 2024. Please then state the number and value of parking fines issued on those days together with number of appeals against these fines received and number of appeals granted.

These parking fines are issued by Coventry City Council and so this information should be readily available.
