

Re: LAPPC Application for Superior Paint and Powder Coating Limited

The Health Protection Agency has received from Coventry Teaching Primary Care Trust an LA-PPC application to operate Superior Paint and Powder Coating Limited. This process principally consists of powder and wet spray industrial finishing operations.

The main emissions of concern are point and fugitive source emissions of particulates and volatile organic compounds (VOCs). However, these emissions are reduced through the employment of fully contained systems, the use of multi-filtration systems and local exhaust ventilation (LEV).

Due to the abatement systems in place, it is unlikely that there will be any impact on local human health receptors from this installation. Nevertheless, we recommend that the Regulator ensure that best available techniques are employed so that the emission limits are met, as set out in the relevant Process Guidance Note.

Local Health issues

Based on the application, this installation does not present any obvious cause for concern providing it is well managed and maintained. However, if you are aware of any health issues in this area we recommend you inform the Regulator.
